Pre-entries: Pre-entries open March 13 (postmark) for Australian Shepherds and March 16 for all other herding breeds. The closing postmark date for entries will be April 1. Random drawing will choose the order of entries with postmarks of the same date. Bitches in season will run in order. A waiting list will be established if the trial fills with names added according to the order of receipt of entry forms by postmark date. **Please include your e-mail address for confirmation of entries. Entries are non-refundable after the closing date.**

ASCA RULES STATE ENTRIES WILL BE FILLED BY POSTMARK DATE ORDER. OVERNIGHT ENTRIES ARE NOT NECESSARY! ENTRIES REQUIRED A SIGNATURE WILL NOT BE ACCEPTED.

Correct amount must accompany entry form. Postdated checks will not qualify as a valid pre-entry. Any checks returned for insufficient funds will be considered a void entry. Stock: 3-5 head commercial beef cattle, 3-5 head commercial hair sheep, 5 head mixed breeds ducks

Weekend awards:

Prizes will be awarded for the following high combined awards. Highest accumulated points for the weekend, qualifying scores only.

HIGH COMBINED WTCH AUSSIE: Dog that has earned the WTCH title before the first trial started

HIGH COMBINED NON-WTCH AUSSIE: dog that has not earned the WTCH title before the first trial started

MOST PROMISING STARTED AUSSIE: All points must be earned in the started classes

HIGH COMBINED OTHER BREED: Highest combined scores over both trials from any division on all classes of stock.

Daily awards:

1st – 4th placed – flat ribbons

Qualifying score ribbons to all qualifiers in Regular classes

Rosettes will be awarded for High scores in Cattle, Sheep, and Ducks, HIT Aussie, HIT Other Breed and High Scoring Junior.

Notice to Exhibitors

This trial is open to all eligible herding breeds under ASCA rules.

Owners of dogs will be responsible for all injuries to livestock. Injury: vet on-call fee. Stock replacement:

Ducks - \$25.00, Sheep \$200.00, Cattle - \$ Market value

Entry fees will not be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, and/or dangerous weather conditions, acts of God, public emergencies, acts of a public enemy, strikes, or other causes beyond the control of HWASC. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by the Trial Committee.

Each owner/handler is responsible for their dog(s). Dogs must be confined or on lead at all times, except when competing. Dogs are not allowed to run loose. Dog owners are required to pick up after their dogs.

Ranch is on the southeast corner of Buck Creek and 700 N. and will be the first drive on the right with the cattle guard.
